

HOW TO KILL THE PEACH BORER. -Pour a small quantity of common sperm oil on the bark of your trees close to the roots without disturbing the earth. Repeat this once in May and the borer will not disturb your tree again this year. If the scaly bug infests the bark of your trees, rub them with an oiled swab and it will be destroyed also. Oil is the most effectual poison for all usects. It closes their spiracles, or breathing holes, on the side of the body. Essential oils, such as camphor and turpentine, kill or drive away insects for the same reason, and not because their order is pungent. A NATIONAL HOME FOR INVALID SOL DIERS .- Measures are now in hand which are calculated, after a lapse of a few months, to establish a National Home for Invalid Soldiers-a much needed institution. The site for the Home has already been purchased, and consists of thirty acres of land, used by Gen. Meade during the battle of Gettysburg as his headquarters. The plan has been approved by Ex-Governor Curtin, Gen. Meade, Governor Geary, and a large number of prominent military heroes. In furtherance of the object, the Pennsylvania Legislature, at its last session, created a corporation with full pewer to erect a home; but the corporators having failed to procure the necessary funds by voluntary subscriptions, now propose to raise the means by a grand gift distribution. 
