RANCID BUTTER. - We copy the following from an exchange, which, as rancid butter s generally in the ascendant here, may be worth at least a trial: "To a pint of water add thirty drops (about half a teaspooful) of liquid chloride of lime. Wash in this two and a half pounds of rancid butter. When every particle of the butter has come in contact with the water, let it stand an hour or two; then wash it well in pure water. The butter is left without any odor, and has the sweetness of fresh butter. These preparations of lime have nothing injurious "them." The editor then adds: "We forthwith obtained some of the most rancid butter, and bad enough for any stomach that had no more sensibility than a wagon wheel. 
