It is estimated that during the last decade the people of the State have been taxed at the rate of two millions and a half of dollars per annum in the purchase of school books. This immense burden was put upon them through the venality or weakness of directors and county superintendents, who ordered changes in books from year to year. This bill will relieve the people from an expense that is at the same time onerous and useless.
