Democratic County Meeting.

In pursuance of the usual notice a large and respectable meeting of the democrats of Clearfield county was held in the court house on Tuesday evening the 2d inst.

On motion, Dr. J. P. HOYT, was called to the chair. SAMUEL JOHNSON, GEORGE WELCH, jr., CHRISTIAN STRAW, FRANCIS COUDERT, Vice Presidents, and George Thorn, Secretary.

On motion, the following committee was appointed to report proceedings for the consideration of the meeting:—Dr. H. Lorain, A. K. Wright, John Stites, John Long, Joseph McMurray, Wm. J. Hinchbill and D. W. Moore.

The committee having retired, in a short time returned with the following report, which was unanimously adopted:—Whereas, Much dissatisfaction exists with a large portion of the demeracy of Clearfield county, as to the manner of choosing the candidates of the party...

First. The candidates announce themselves to the public through the columns of a county paper.

Second. On a day appointed by the Standing Committee the Democratic voters of each township and borough in the county, meet at the usual place of holding the General election...

Third. It shall be the duty of the Clerk to keep a correct copy of the list of voters—and after the polls are closed, and the votes counted, it shall be the duty of the Judge and Clerk to certify to the same.

Fourth. The returns so made out, are to be delivered to the Chairman of the Democratic Standing Committee, on or before the Tuesday evening of the September Court—unless otherwise ordered by a majority of the Standing Committee...

Fifth. The returns of the election for choice of candidates shall be read by the Chairman or Secretary of the Standing Committee, in public County Meeting, on the said Tuesday evening of the September Court—unless otherwise ordered as above provided.

Sixth. The candidates having the highest number of votes for each office shall be considered the candidates of the party, and shall constitute the Democratic Ticket—and the party shall be as firmly bound to sustain them at the General Election as if they had been nominated through the system we have heretofore practiced.

The above system has hitherto been partially practiced in some of the townships of this county; and we believe, if brought into full practice, would prove to be the best and most unexceptionable plan by which a party can ascertain the will of a majority of its members.

Resolved, That we recommend that the above plan be submitted to the consideration of the people of the county, and that a general Democratic county meeting be held on Tuesday evening of the next February court, to which meeting shall be submitted the question of its final adoption or rejection.

Whereas, Since the elevation of James K. Polk to the Presidency, and Francis Pickens to the gubernatorial chair of this Commonwealth, our country has suffered none of the evil and destructive consequences predicted by the federal party, but on the contrary, the past has been a season of unparalleled prosperity with all the great leading interests throughout the country.

The labor of the husbandman has been blessed with an abundant reward—manufacturers and the mechanic arts have flourished, and our commerce has continued to stretch her wings in every sea. Therefore

Resolved, That we continue to have the utmost confidence in the General and State administrations, and that we believe the honor and welfare of the country are safe in their hands, whether threatened by bank and money corporation influence on the one hand, or British thunder on the other.

Resolved, That this meeting is in favor of retaining every foot of Oregon, to which we have a title, and extending our laws over it as soon as it can possibly be done.

Resolved, That we are in favor of Mr. Whitney's project of a railroad to Oregon, and would like to see Congress pass an act by which it might be commenced immediately.

Resolved, That our Senator and Representatives are hereby instructed to vote against rechartering either of those swindling institutions—the Girard or United States Bank—in every stage and under every form in which they may come up before them.

Resolved, That they be instructed to vote against the re-charter of any Bank unless the stockholders are made liable in their individual capacities for all their issues—and also, not to vote for any money making corporation without making the stockholders individually liable for all their debts.

Resolved, That we are opposed to increasing the number of Banking institutions in our State.

On Motion, The following gentlemen were appointed the Democratic Standing Committee for the ensuing year, viz:—Dr. H. Lorain, J. W. Wright, Henry B. Beissel, Martin Nichols, Jr., Abraham Keyler, John McPherson, D. W. Moore.

On motion, the proceedings were ordered to be published—when the meeting adjourned.
