

Beware of Chartered Privileges.

ANOTHER FALSEHOOD EXPOSED.

Mr. Smith, the Federal candidate for Congress, in his speech in this place, said that the friends of Gen. CASS, in the late session of Congress, refused to allow an investigation of his accounts as Governor of Michigan, &c. Now, it should be remembered that the Whigs had a majority in the House, and could investigate what they pleased, in defiance of the Democrats. The *Washington Union*, in an able exposition of the falsehoods in Andy Stewart's late speech in Congress, likewise exposes this rascal of Mr. Smith's in the following paragraph. The *Union* gives the amount of "extras" received by Gen. Taylor, which amount, in the aggregate, to \$25,708 30.

Mr. S. appends to his speech a vote in the House of Representatives, on a resolution submitted by him, calling for information in relation to Gen. Cass's accounts, to show that the inquiry was resisted by that gentleman's friends; but we suppose it was not convenient for him to state all the facts, viz: that this resolution was opposed only for the purpose of having it amended so as to embrace Gen. Taylor's accounts and allowances also; that when so amended, it was at first opposed by his friends, but that it was finally adopted, because they dare not encounter the inferences that would be drawn if they prevented its passage; that the information called for in both cases was duly furnished by the Secretary of War and accounting officers; BUT THAT GEN. TAYLOR'S FRIENDS, HAVING THE MAJORITY, TOOK GOOD CARE THAT IT WAS NOT PRINTED, it having been referred to the Committee on Public Expenditures, where it lies buried from public view.

Will the *DuLler County Whig* just recall that story, pleasant little lie it told so conspicuously about the gallant General QUITMAN being an advocate of General Taylor's election?

"The people of the North, therefore, must take the assertions of Mr. Peyton as sincere, and as fully explanatory of the feelings of the Whig candidate for the Presidency, upon the great Proviso question, and as a southern

SENATE.—There are 14 Senators elected.—3 Whigs, and 11 Democrats. The remaining 17 will be elected by a convention of the two Houses, and as the House of Representatives has a majority of Democrats, the Democratic candidates will be chosen.

HOUSE OF REPRESENTATIVES.—The House consists of 151 members, and are elected thus:—Democrats, 85; Whigs, 53; Free Soil, 12; and one who styles himself a Taylor Democrat.

One of the delegates from this State to the Baltimore Convention in May last, pledged the vote of Maine to Cass and Butler by ten thousand majority! The vote on Monday last renders it evident that the pledge will be gloriously redeemed—it will be more than redeemed.— Maine will give Cass and Butler a majority over the Federal ticket in November, of more than eleven thousand! Taylor cannot get the vote which Hamlin received last Monday; and Cass will receive a larger vote than that given to Dana.

A DISTRESSING PICTURE.

State of Ireland.—Irish papers still contain accounts of misery and crime, resulting from the destitution of the people and eviction from their homes. The *Limerick Examiner* says:—"The poor in the town of Bull and its immediate vicinity are obliged to undergo severe privations, and shocking instances of extreme destitution are of daily occurrence. A few days since a man named McNamara dropped suddenly in the street, not having taken of proper nourishment for four days, his only diet being one meal of cabbage." The *Limerick Reporter* says that over sixteen hundred paupers, receiving outdoor relief in Milltown Malbay, were struck off the list last week, and asks, "what in the name of heaven will become of those who have not one morsel of any kind of food to support their famishing families?"

The same paper, states that in Tipperary, during the present week, wholesale evictions had taken place. In Clare, also, the sheriff had proceeded to the lands of Broughda, and dispossessed 29 individuals from their homes. The cries of the unfortunate outcasts were heartrending, and continued for hours. The value of the crops on the land much exceeded the amount of rent due, with the exception of a sum charged as arrears.

The *Wexford Guardian* chronicles the wholesale eviction of an ancient and numerous people, the Keanees, in the county of Waterford.

The details of crime are almost too shocking to repeat. One paper states that a poor man, who was cut off the relief list, having no means of support, went into a potato garden at Maylass, in the county of Clare. The son of the owner set a large dog at the poor man, which (horrible to relate) knocked him down, tore him open, and actually devoured a part of his entrails. The inhuman wretch who set on the dog, looked on carelessly on.
