Information for and Instructions to CLAIMANTS. All Soldiers of the present war, who have served two years, and Soldiers discharged for wounds received in battle, without reference to the date of discharge, are entitled to their regular pay, to \$1000.

In case of Soldiers or Seamen discharged for disability or wounds received while in the service, they are entitled to a Pension according to the Government.

In case of the death of the Soldier before discharge, through disease contracted, or wounds received while in the service, the widow is entitled to a Pension, if dependent on him wholly or in part for support.

If the Soldier die after discharge, from disease contracted or wounds received while in the service, his widow is entitled to a Pension of \$96 per annum.

If no widow or minor children, the mother of the Soldier is entitled to the same benefits as the widow, except when the Soldier was discharged for disability.

If no widow or minor children, the bounty and pay will descend to the heirs as follows: First to the Father, second to the Mother, third to the Brothers and Sisters, and last to the next of kin.

Discharged Soldiers, whose clothing account was unsettled at the time of discharge, can recover any balance due them. If the Company books are not destroyed, To show this balance, the Soldier must produce a descriptive list, showing Clothing account, and forward it to me with your preliminary statement, giving also the date of your discharge.

Soldiers who served with the nine months' volunteers, can recover \$27 bounty and premium, without regard to time of service, if they have not already received it.

Soldiers who were present at the battle of Gettysburg, and who were absent on sick leave, are entitled to commutation of rations.

In communicating with this office, state the nature of your claim, and send the original of the receipt, together with your present Post Office address.
