PHILADELPHIA LOYAL TO THE UNION.

Mayor Henry has issued the following proclamation :

OFFICE OF THE MAYOR OF THE CITY OF PHILADELPHIA .- PROCLAMATION .-Citizens of Philadelphia .- Treason against the State of Penn-givania, or against the United States, will not be suffered within this city; nor will violence to the persons or property of the inhabitants be tolerated.

I do hereby require all good citizens to disclose and make known to the lawfui authorities every person rendering, in this city, aid to enemies in open war against this State and the United States by enlisting or procuring others to ealist for that purpose, or by furnishing such enemies with arms, ammunition, provisions or other assistance.

I do hereby require and command that all persons shall refrain from assembling in the highways of this city, unlawfully, riotously or tumultously, warning them that the same will be at their peril. The laws of our State and Federal Government must be obeyed--the peace and credit of Philadelphia shall be preserved. May God save our Union. Given under the seal of the city of Philadelphia, this sixteenth day of April, one thousand eight hundred and sixty-one.

PRESIDENT DAVIS' PROCLAMATION.

MONTGOMERY, April 18 .- President Davis has issued a proclamation, giving giving notice that the Government will issue letters of marque and reprisals against the commerce of the North. The proclamation concludes as follows :- "And I do moreover solemnly exhort all good people of these Confederate States, as they love their country, as they feel the wrongs of the past, and those now threatened, in an aggravated form, by those whose enmity is more implacable because unprovoked, that they exert themselves in preserving order, in promoting concord, in maintaining the authority and efficiency of the laws, and in supporting and invigorating all the measures which may be adopted for the common defense, and by which, under the blessings of Divine Providence, we may hope for a speedy, just and honorable peace.


