LOCAL MILITARY MATTERS .- The several companies composing the Cambria County Regiment, now at Camp Curtin, are rapidly Elling up, and their full complements will soon be obtained. This regiment will be the first to receive marching orders from that point, and these desiring to "see service" shortly should enlist in it forthwith. The field officers, Col. Campbell, Lt. Col. M'Dermitt, and Maj. Linton, are practical military men, the Colonel and Major having served in the three months' campaign, and the Lt. Colonel in the Mexican war. They are widely known throughout the entire county, and possess in the fullest degree the respect and confidence of the people. The "Frosty Sons' could not possibly find a better field for the display of their patriotism than in the ranks of this regiment.

Company F. of Col. Geary's regiment, is formed by the merging of two parts of companies, hailing respectively from Gallitzin, this county, and Allegheny county. The officers are as follows : Captain, Jos. B. Copeland, of Allegheny; First Lieutenant, David Mills, of Cambria; Second Lieutenant, Caleb Greenwalt, of Allegheny: First Sergeant, Peter Kaylor, of Cambria. At latest accounts, they were stationed at Point of Rocks, Maryland.
