In Mrr. Hall's book on Ireland, occurs the following passage, which a person will hardly read without emotion : We entered one day a cottage in the enburbe of Cork; a young woman was knitting stockings at the door. It was as neat and comfortable as any in the most prosperous district of England. We tell her brief story in her own words as nearly as we can recall them : "My husband is a wheelwright, and always carned his guinea a week ; he was a good workman, but the love of the drink was strong in him, and it wasn't often he brought me home more than five shillings out of his one pound on a Saturday night, and it broke my heart to see the children too ragged to send to school, to say nothing of the starved look they had out of the little I could give them. Well, God be praised, he took the pledge, and the next Saturday he laid twenty-one shillings upon the chair you sit upon. Oh ! didn't I give thanks upon my bended knees that night; still, I was fourful it wouldn't last, and I spent no more than the five shillings I used to, saying to myself, maybe the money will be more wanted than it is now. Well, the next week he brought me the same, and the next and the next, until eight weeks had passed, and, glory to God ! there was no change for bad in my husband; and all the while he never asked me why there was nothing better for him out of his earnings ; so I felt there was no fear for him, and the ninth week, when he came these six chairs, four for the children and opposite Thompson's Hotel. one for himself; and I was dressed in a new gown, and the children all had new clothes and shoes and stockings, and upon his chair I put a bran new suit, and upon his plate I put the bill and receipt for all of them. just the eight sixteen shillings, the cost that I'd saved out of his wages. not knowing what might happen, and that always went for drink. And he cried, good lady and good gentleman, he cried like a baby, but 'twas with thanks to God; add now where's the healthier man than my husband in the whole county of Cork, or a happier wife than myself, or decenter or better fed children than my own ?"




