PARTURE FROM HUNTINGDON-TO HOPEWELL -CAMP "MULLIN"-AN INNOCENT "GOAK" -H. & B. T. BR .- PROMOTIONS, ETC., ETC. CAMP MULLIN, BEDFORD Co. August 1, 1868.

Correspondence of The Alleghanian. credence that the Rebels, as a sort of last dying gasp, anticipated making a raid into Fulton county, on Tuesday 29th ult., Col. M'Keage's command, consisting of Maj. Litzinger's and Col. Crozier's battallions, were ordered to Hopewell, to keep an eye upon the movements of the greybacked gentry. We left camp at Huntingdon at 2 P. M. of that day, taking the cars on the Huntingdon & Broad Top Railroad at about 6. In due course of time, that is to say, at about midnight, same night, we were landed at our destination, sound in mind and members, but all very tired and sleepy. Seeing that the distance from Huntingdon to Hopewell is ply thirty-one miles, and that six hours rere consumed in achieving the distance, person might naturally fail to be favorably impressed, as regards the matter of need, with the schedule of the H. & B. R. R. But your correspondent is credibly informed that the fault in the premises, if fault there be, was not altogether with the railroad. Its regular time, instead of five miles an hour, is mobably twice that figure. The fact is, o are limited to our snail-like pace amply by reason that it was thought isable to allow the Rebels, in case they prostrated at all, to penetrate as far as esible into the interior of the State, were we would suddenly and unexpectedburst upon them, like an avenging agel of destruction, scattering them nght and left, and "gobbling up" the mire kit and caboodle after the most
