

opening of each meeting, determine by roll call the number of active members present in order that the presence of a quorum may be decided. He shall carry on all correspondence not within the province of either of the Departments.

SECTION 4.—It shall be the duty of the Treasurer to collect all fees, dues, and assessments, to receive donations and, from the managers, the receipts from all Athletic events, to keep a full and correct account of all money received and paid out, under four separate heads:—Association; Football; Baseball; and General Athletics. Under the head of Association account shall all items not belonging to either of the other accounts be entered. He shall pay out money from the Association account only upon written order from the President, and from the several Departments accounts upon written order from the respective managers. Nor may he transfer money from one account to another without a two-thirds vote of the Association.

SECTION 5.—It shall be the duty of the Board of Auditors to examine the books of the Treasurer whenever so directed by the Association, and at the end of each term. In each case the result shall be reported to the Association.

ARTICLE V.

SECTION 1.—All elections shall be by ballot.

SECTION 2.—All ballots must be cast in person.

SECTION 3.—The candidate receiving a majority of all legal votes cast shall be declared elected.

SECTION 4.—If on the first ballot no candidate has received a majority of all legal votes cast, on the second ballot all except the two candidates receiving the highest number of legal votes cast, shall be dropped.

SECTION 5.—At least twice as many persons shall be nominated for each office as are required to fill it.

SECTION 6.—The names of all nominees must be handed to the Secretary and published by him at least one week before the election.

SECTION 7.—When a vacancy occurs in an office a successor shall be elected as soon as possible.

ARTICLE VI.

SECTION 1.—Assessments may be laid by a two-thirds vote of the active members.

ARTICLE VII.

The Association may on a two thirds vote of the active members direct the Treasurer to transfer funds from one account to another.

ARTICLE VIII.

Should any officer or member of a Committee neglect, or be found incompetent to discharge the duties of his office he may be removed by a vote of two-thirds of the active members.

ARTICLE IX.

SECTION 1.—The Football Department shall be governed by a Board of Directors composed of three elected members, Captain and Coach, members *Ex-Officio*, and the manager a lay member.

SECTION 2.—The Association shall, on the second Monday of the winter term, elect a Manager, a Marshal, and a committee of three for this Department.

SECTION 3.—It shall be the duty of the Manager to make

and accept all challenges and to attend to all business matters incident to the Department. He shall deposit, without delay, all money he may receive belonging to the Department, with the Treasurer, and shall issue orders on the same for the payment of all debts contracted by the Department.

SECTION 4.—It shall be the duty of the Marshal to take charge of all goods when not in use and trophies belonging to this department.

SECTION 5.—The duties of the Board of Directors shall be to select the team, to advise with the Captain in the placing of the selected men, and to act as an advisory committee to the Manager.

SECTION 6.—Before the Saturday following Thanksgiving day the team shall elect a Captain for the next season.

SECTION 7.—The word "team," wherever used, shall mean the regular players and substitutes as selected by the Board of Directors.

ARTICLE X.

The control of the Baseball Department shall correspond to that of the Football Department, *excepting* the Captain for the next year shall be elected on the Saturday preceding commencement and the Manager, Marshal and Committee shall be elected on the first Monday after Thanksgiving Day.

ARTICLE XI.

The control of the General Athletic Department shall correspond to that of the Baseball Department, *excepting* the Manager, Marshal and Committee shall be elected the first Monday in October.

ARTICLE XII.

No person shall represent this Association in any athletic contest or game, either at the College or elsewhere, unless such person be at the time an active member.

ARTICLE XIII.

Any part of the Constitution or By laws may be amended or repealed by a four-fifths (4/5) vote of all active members, providing that the proposed change shall have been published at least two weeks before.

ARTICLE XIV.

This Constitution and By-laws shall go into effect September 1st, 1895, and all officers then serving and fulfilling the requirements shall retain office until the same expire under this Constitution and By-laws.

BY-LAWS.

ARTICLE I.

SECTION 1.—This Association shall call its meetings at such time and such place as the President may direct.

SECTION 2.—The President shall hold a meeting at the request of three members.

SECTION 3.—Forty per cent. of active members shall constitute a quorum.

SECTION 4.—At the opening of each meeting the President shall designate the section of seats to be occupied by active and associate members respectively.

ARTICLE II.

SECTION 1.—Each active member shall be required to pay yearly dues of one dollar.

SECTION 2.—Said yearly dues must be paid before October first of each year.
