The management expects to have Allegheny College here either the first or last week of February.

This is surely a hard schedule and it is hoped that the Faculty will approve it as it is. Since but two men of last year's team are in College at present, it will take some strenuous effort on the part of Captain Waha, '09 to make a successful season. It is not too early to urge every man in college, who has ever played basket ball before, to try for the team and develop a winning Varsity. The Collegian suggests that a coach

be employed this year, some graduate as "Billy" Dunn, '05, Foltz, '06, Yeckley, '06. Heretofore, the men have had to depend upon the advice and inspiration of their captain alone. But the large amount of new material this year will give Captain Waha more than he can well attend to.

The Recent Mass Meeting.

A number of matters of general interest were acted upon at a meeting of the student body after chapel on Monday. A peculiar interest was attached to this meeting because of the fact that it was the first one to be held under the auspices of the student members of the council of administration.

It was voted to cease cutting campus, not only during the winter, but until such a time in the spring as is thought necessary to prevent any possibility of wearing paths. The destruction of any college property of value during celebrations was forbidden. The presidents of the three upper classes were constituted a board of appeal, to decide what is valuable property, in cases of dispute.

The matter of paying college fees by semesters, instead of by terms, as is now the custom, occasioned considerable discussion, but action was postponed pending further investigation.

For convenience of the athletic teams, it was decided that during practice and scheduled games the student body should keep back on the track during football contests and on the outside of the track during other events. In this connection, the matter of new bleachers was again brought up, but no action was taken.

Brass Cannon on the Campus.

The suggestion made by "A Reader" in last week's issue has been followed up by the Collegian and has already assumed a definite form. At the present time a member of the Senior class is designing a base upon which to mount the cannon. As soon as completed these plans will be turned over to Captain Hay for his approval, and will then be given to the Board of Trustees.

General Beaver has heartily approved the idea and Captain Hay thinks that the expense of construction will be assumed by the College if the plans are satisfactory. It has been suggested that the cannon be placed, one on each side of the flower bed, in front of the Main building. In such a position they will add to the beauty of the campus of which we are so proud.
