Article VIII. The managers shall keep a full record of all games and this record shall be published in the State Collegian.

Article IX. The class teams may practice on the gym floor at any time that does not interfere with varsity practice.

Article X. The class teams shall play with the varsity in their turns at the times scheduled by the schedule committee.

Article XI. There shall be a cup on which shall be engraved the numerals of the class winning the championship.

Article XII. Each class may choose its awards to individual players as it sees fit, only on condition that it has played the full number of games.
