

News from other Colleges

A Junior at the University of Minnesota is offering to secure dates for Junior girls who are willing to go fifty on the price of tickets for ball games.

Students at the University of Kansas from now on will have no excuse for being late to classes. The University has installed a flimsy service at its own expense, and a decrease of 50 per cent in tardiness has already been noted.

Nearly all of the schools and colleges which were established in the Turkish empire prior to the outbreak of the war are now closed. The list includes 1000 grammar schools and 13 colleges.

Students of the University of Montana who served on the Mexican border with the National Guard are now enjoying their schooling without charge. The state has eliminated the usual fee.

After wrangling for nearly an hour over the proper parliamentary procedure, 589 students of the University of Kentucky recently appointed a committee to act with Dean Arthur M. Miller, of the faculty, in investigating the financial status of athletes at the University. The committee was charged to report to the students the advisability of levying an extra fee of \$2.50 on each student.

Each year the student annual at the University of Texas includes a beauty section among its contents. The belles of the University are photographed and their pictures are given a distinctive setting. This year the question of selecting the university beauties will be submitted to popular vote. Each male student of the university will be permitted to cast his ballot for the four girls whom he considers to be the easiest to look upon.

More than 300 students at the University of Illinois have gone on record as being in favor of the use of wrist watches. A petition was circulated and no trouble was experienced in securing names.

Bread and milk is the menu for the annual banquet at which the freshmen are entertained at the University of Wisconsin.

Fifty cadets of the United States Military Academy at West Point were dismissed recently because of failures in the annual mid-year examinations. Most of the men dismissed were plebes. The Dean of Women at Northwestern University has forbidden the women students on pain of expulsion to give their photographs to newspapers or to allow reporters to interview them. The allow reporters to interview them. The sensational versions of Northwestern happenings that have been constantly appearing in the Chicago newspapers have probably been the cause of the ruling.

According to figures which have recently been published, football coaching costs the University of California \$12,000.

Seven freshmen of the Oregon Agricultural College have refused to accept varsity letters which were awarded to them because they felt that their acceptance would not meet with the approval of the student body.

The students of Beloit College recently voted to abolish the honor system. The petition is now in the hands of the faculty for final action.

COLLEGIAN CONSTITUTION

(Continued From First Page)

ARTICLE 2
Section 1—The PENN STATE COLLEGIAN shall be published by the students in the interests of the students, alumni, faculty, and friends of the PENNSYLVANIA STATE COLLEGE.

Section 2—The time of publication, and the number of issues in each college year, shall be decided by the then governing BOARD.

ARTICLE 3
Section 1—The governing power of this organization shall be vested in a BOARD, as hereinafter provided for.

Section 2—This BOARD shall be composed of students regularly enrolled in any one of the four year courses in the PENNSYLVANIA STATE COLLEGE, who have been elected according to the methods hereinafter described.

Section 3—The BOARD shall be divided into two departments, namely:
(1) The Editorial Department
(2) The Business Department

The Editorial Department of the BOARD shall consist of an Editor-in-Chief, an Assistant Editor, and an Associate Editor, all of whom shall be Juniors; and three Associate Editors, all of whom shall be Juniors. The Business Department of the BOARD shall consist of a Business Manager, a Circulation Manager and an Advertising Manager, all of whom shall be Juniors; and three associate members of the Business Department all of whom shall be Juniors.

Section 4—After their election to the BOARD, Sophomores shall be regarded as Juniors, and Juniors shall be regarded as Seniors.

Section 5—The existing BOARD shall elect the new BOARD; and only members of the BOARD shall have the right to vote on matters pertaining to the paper.

A quorum shall consist of three-fourths of the active members of the BOARD.

Section 6—There shall be a STAFF of the aforementioned organization, which shall consist of the Editor-in-Chief and such other students properly qualified, who have been elected to the STAFF by the members of the Department of the BOARD in which they are associated. Election to the STAFF shall be secured by competition only.

Section 7—The Editor-in-Chief or the Business Manager may, at his discretion, issue a call for candidates to try out for positions on the Department of the STAFF with which he is associated. After due competition of such candidates he shall submit to the members of his Department of the BOARD, a list of suitable candidates, together with his recommendations, and that Department of the BOARD shall elect from said list the desired number of candidates to the STAFF.

Section 8—Votes for all elections shall be taken by secret ballot. Absent members may vote by proxy. Section 9—In the selection of candidates the following qualities shall be taken into account:
(1) Ability
(2) Personality
(3) Scholarship
(4) General attitude towards activities

ARTICLE 4
Section 1—There shall be a meeting of the BOARD at least once in every

two weeks.

Section 2—The Editor-in-Chief shall be the chairman of all such meetings.

Section 3—The time for election to the BOARD and for change of BOARD shall be between February 20th and March 1st of each year, as determined by the BOARD.

Section 4—In elections to the BOARD, candidates shall not vote in elections in which they are contestants. All candidates shall leave the room in which the elections are being held during the time they are being voted on. If no man receives a plurality in elections to the BOARD, then from the two highest on the list the BOARD shall elect. In case of a tie here, the Senior Editors and the Senior Managers shall decide for the offices in their respective Departments.

Section 5—Officers of the BOARD shall be as follows:
President—Editor-in-Chief
Vice President—Assistant Editor
Secretary—Circulation Manager
Treasurer—Business Manager

ARTICLE 5
Section 1—The Business Manager shall make to the BOARD a detailed financial report every second month of the college year.

Section 2—The members of the retiring Business Department of the BOARD shall be ex-officio members of the new BOARD to the end of the college year, and shall have control of all finances until that time.

Section 3—All members of the outgoing BOARD, shall be presented with a medal of some appropriate design in recognition of their services to the organization at the beginning of their Senior year. The Commemorative (if there be such) shall be presented with a similar medal at the end of his Senior year.

ARTICLE 6
Section 1—All amendments to this constitution shall require a three-fourths vote of the then existing BOARD.
