The Lorch Case

This is an appeal for reconciliation in the Lorch case.

It is an appeal for sensible action to end the embarrassing situation in which the College finds itself.

Although little has been said by College officials on the Lorch case, and although Dr. Lorch's testimony is far from conclusive, there is evidence that much difficulty arose from misunderstanding of motives and false conceptions of fact and attitudes.

BY FOLLOWING ITS POLICY of revealing virtually nothing about a case which has attracted widespread attention, the College has left itself wide-open for criticism and doubt concerning its motives. Even though its motives may be good, remaining silent on the subject is of no value to the public relations of the College.

To clear the air and disentangle the confusion which now exists, a definite statement of the College's position and its view of the facts is needed. By continuing its passive attitude, the College is endangering its reputation on academic freedom, which has been good to date.

The Pennsylvania Federation of Labor came up with the best plan yet by proposing an impartial hearing on the case. At such a hearing, which certainly should be an open one, the College could make its position known and the facts could be gone over in a less heated atmosphere. Such a reevaluation of facts is badly needed at this date.

THERE IS EVIDENCE IN SOME quarters that Dr. Lorch would not be opposed to an attempt at reconciliation. From the evidence at hand, there seems to be no reason why the College should not give serious consideration to such a suggestion.

If mistakes have been made, a sincere attempt at reconciliation would go a long way toward clearing them up and producing a more healthy atmosphere. If a hearing should reveal past mistakes, the prestige of the College among thinking people would be greatly enhanced by a reconciliation.

The Lorch case has developed into a nasty situation which has no comfort for either side. For the good of the College and education in general, every effort should be made to reach a just and reasonable conclusion.
