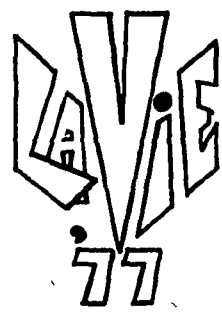
## Together.

### "advocacy in the past"

Constant regular rap sessions, night and day, with students during Cambodian bombing, Kent State era. Spring 1970

First vote for students' representatives on committees of PSU Board of Trustees beginning in July 1970.

Concern for disadvantaged unrepresented students at PSU leading to establishment of Renaissance Fund at Penn State and a member of the board of the fund since 1970.

Regular advocate for open Board of Trustees meetings and open Board committee meetings culminating in successful vote. September 1976.

Proposed and voted for negative check-off for Penn-PIRG, summer 1975

Constant advocate of lower tuition for Penn State students, including 6 "no" votes on PSU Board of Trustees. Attendance at every tuition rally held at PSU.

Chairperson of PSU Board of Trustees Affirmative Action Committee since establishment in 1974.

Served on the National Advisory Committee for Student Involvement in Collective Bargaining, 1974-75.
