

PROCLAMATION.
Notice of General Election.
PURSUANT to an act of the General Assembly of the Commonwealth of Pennsylvania, entitled "An act relating to the election of this Commonwealth," approved the second day of July, 1855, JOSHUA GREENLAND, High Sheriff of the county of Huntingdon, in the State of Pennsylvania, do hereby make known and give notice to the electors of the county aforesaid, that a

GENERAL ELECTION
will be held in the said county of Huntingdon on the **SECOND TUESDAY**, (and 9th day) of October, 1855, at which time, State and County officers, as follows will be elected to wit:
One person to fill the office of Canal Commissioner of the Commonwealth of Pennsylvania.
Two persons in connection with the county of Blair to fill the office of Members of the House of Representatives.
One person to fill the office of Treasurer for Huntingdon county.
One person to fill the office of County Commissioner for Huntingdon county.
One person to fill the office of Director of the Poor for Huntingdon county.
One person to fill the office of Auditor for Huntingdon county.
One person to fill the office of Coroner for Huntingdon county.

In pursuance of said act, I also hereby make known and give notice, that the places of holding the aforesaid general election in the several election districts within the said county of Huntingdon, are as follows to wit:
1st district, composed of the township of Henderson, except the borough of Huntingdon, and also a part of Porter township, and a part of Walker township, not in the 15th district, at the Court House in the borough of Huntingdon.
2d district, composed of Dublin township, at Pleasant Hill School House near Joseph Nelson's, in said township.
3d district, composed of so much of Warriors-mark township, as is not included in the 19th district, at the school house adjoining the town of Warriors-mark.
4th district, composed of the township of Hopewell, at the school house at Rough and Ready furnace.
5th district, composed of the township of Barre, at the house of James Livingston, in the town of Salsbury, in said township.
6th district, composed of the Borough of Shirleyburg, and all that part of the township of Shirley not included within the limits of District No. 24, as herein-after mentioned and described, at the house of David Fraker dec'd., in Shirleyburg.
7th district, composed of Porter and part of Walker townships, and so much of West township as is included in the following boundaries, to wit: Beginning at the south west corner of Tobias Cauffman's Farm on the bank of the Little Juniata river, to the lower end of Jackson's narrow, thence in a northwesterly direction to the most southerly part of the farm owned by Michael Maguire, thence north 40 degrees west to the top of Tussey's mountain to intersect the line of Franklin township, thence along the said line to Little Juniata river, thence down the same to the place of beginning, at the public school house opposite the German Reformed Church, in the borough of Alexandria.
8th district, composed of the township of Franklin, at the house of Geo. W. Mattern, in said township.
9th district, composed of Tell township, at the Union school house, near the Union Meeting house in said township.
10th district, composed of Springfield township, at the school house near Hugh Madden's in said township.
11th district, composed of Union township, at the school house near Ezekiel Co. bin's in said township.
12th district, composed of Brady township, at the Centre School House in said township.
13th district, composed of Morris township, at the public house lately occupied by Peter Heinselman, in the village of Waterstreet, in said township.
14th district, composed of that part of West township, not included in 7th district, at the public school house on the farm now owned by Miles Lewis, (formerly owned by James Bonis) in said township.
15th district, composed of that part of Walker township lying south west of a line commencing opposite David Corbin's house, the Union township line, thence in a straight line, including said Corbin's house, to the corner of Porter township, on the Huntingdon and Woodcock valley road, at the house of Benjamin Magahy, in said township.
16th district, composed of the township of Tod, at the Green school house in said township.
17th district, composed of that part of West township on the south side of Warrior ridge, beginning at the line of West and Henderson townships, at the foot of said ridge, to the line of Barre and West townships to the summit of Stone mountain, to intersect the line of Henderson and West townships, thence by side line to the place of beginning, at the house now occupied by Benjamin Corbin, on Murray's Run.
18th district, composed of Cromwell township, at the house now occupied by David Etnire, in Orishon.
19th district, composed of the borough of Birmingham, with the several tracts of land near and attached to the same, now owned and occupied by Thomas M. Owens, John K. McCallan, Andrew Robison, John Genesier, and William Genesier, and the tract of land now owned by George and John Schoenberger, known as the Porter tract, situated in the township of Warriors-mark, at the public school house in said borough.
20th district, composed of the township of Cass, at the public school house in Cassville, in said township.
21st district, composed of the township of Jackson at the house of Robert Barr, now occupied by Henry Selfridge at McAlcay's Fort, in said township.
22d district, composed of the township of Clay, at the house of Joshua Shore, at the Three Springs in said township.
23rd district, composed of the township of Ponn, at the Public School House in Marktesburg in said township.
24th district, composed and created as follows to wit: That all that part of Shirley township, Huntingdon county, lying and being within the following described boundaries, namely: beginning at the intersection of Union and Shirley townships lying with the Juniata river, on the south side thereof; thence along said Union township line for the distance of three miles from said river; thence easterly by a straight line to the point where the main from Eby's mill to Germany valley, crosses the summit of Sandy ridge; thence northwardly along the summit of Sandy ridge to the river Juniata, and thence up said river to the place of beginning, shall hereafter form a separate election district. That the qualified voters of said election district shall hereafter hold their general and township elections in the public School House in Mount Union, in said district, that Samuel Eby is hereby appointed judge, and Doctor Alrc'd B. Lee and Samuel Miller, esquire, are hereby appointed inspectors of said election, to perform the duties of their several offices until a judge and inspectors are

duly elected, in accordance with the election laws of this Commonwealth.
25th district, composed of the borough of Huntingdon, at the Court House in said borough.
I also make known and give notice, as in and by the 13th section of the aforesaid act I am directed, "that every person, excepting justices of the peace or shall hold any office or appointment of profit or trust under the government of the United States, or of this State, or of any city or incorporated district, whether a commissioned officer or agent, who, is or shall be employed under the legislative, executive or judiciary department of this State, or of the United States, or of any city or incorporated district, and also, that every member of Congress, and of the State Legislature, and of the select or common council of any city, commissioners of any incorporated district, is by law incapable of holding or exercising at the same time, the office or appointment of judge, inspector or clerk of any election of this Commonwealth, and that no inspector or judge, or other officer of any such election shall be eligible to any office to be then voted for."
Also, that in the 4th section of the act of assembly, entitled "an act relating to executions and for other purposes," approved April 16th, 1840, it is enacted that the aforesaid 13th section "not be so construed as to prevent any militia of fier or borough officer from serving as judge, of inspector or clerk, of any general or special election in this Commonwealth."
Pursuant to the provisions contained in the 67th section of the act aforesaid the judges of the aforesaid districts shall respectively take charge of the certificate or return of the election of their respective districts, and produce them at a meeting of one of the judges from each district, at the Court House in the borough of Huntingdon, on the third day after the day of the election, being for the present year on Friday the 13th of October next, then and there to do and perform the duties required by law of said judges. Also, that where a judge by sickness or unavoidable accident, is unable to attend said meeting of judges, then the certificate of return aforesaid shall be taken in charge by one of the inspectors or clerks of the election of said district, and shall do and perform the duties required of said judge unable to attend.
Also, that in the 61st section of said act it is enacted that "every general and special election shall be opened between the hours of eight and ten in the forenoon, and shall continue without interruption or adjournment until seven o'clock in the evening, when the polls shall be closed."
