

### A HERO GONE

Pennsylvania is called upon to mourn the loss of one of her truest and bravest sons. Major General John F. Reynolds was killed in the battle at Gettysburg on Wednesday last. While gallantly fighting at the head of his command, General Reynolds was a brave and accomplished officer. He was born in Lancaster in 1820. He graduated at West Point in 1841, and entering the third artillery, soon took a high position in the army. In the Mexican war he won considerable distinction on account of his bravery, and passed through the bloody battles of Monterey and Buena Vista. Ever since the breaking out of the present civil war he has been in active service, and in every position in which he was placed he distinguished himself by his coolness, his courage, and his ability. As an officer he was greatly beloved; and the many friends who now weep at his loss, will bear willing testimony to his many excellent qualities of head and heart. Pennsylvania will do honor to his memory. His name will be fondly cherished as one of her noblest sons. Yielding up his life in the cause of his country he loved so well, he has proven himself a hero; and the future historian will inscribe upon the records of the times no brighter name than that of Major General John F. Reynolds.

### Privileges for Re-Entering Soldiers.

The government has decided, in General Order No. 216, that all able-bodied men between eighteen and forty-five years of age, who have heretofore been enlisted and have served for not less than nine months, who have been honorably discharged and can pass the examination required by the mustering-regulations of the United States, may be enlisted in any regiment they choose, new-old, and when mustered into the United States service will be entitled to the \$402 provided for recruiting volunteer soldiers. This \$402 comprises \$200 cash, \$100 bounty, \$100 bounty, and \$200 bounty. A regiment, battalion or company of those recruits will bear the title of Veteran Volunteers. The same benefit will be given to men who enlisted prior to Order No. 191, provided the conditions therein set forth are fulfilled. -New York Tribune.
