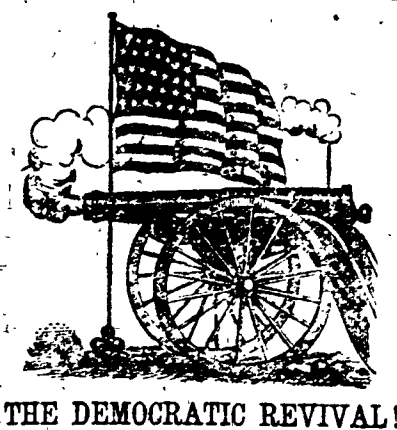

THE DEMOCRATIC REVIVAL!

The returns from the different towns in this State show the most surprising Democratic gains over the vote of last fall.

The Democracy of York, on Friday week, re-elected David Small, Esq., of the Gazette, Chief Burgess, by the unprecedented majority of 378—a gain of 147 since October!

At the municipal election in the borough of Danville, Dr. Stimpson was elected Burgess by a majority of 49. Last fall the Republicans carried Danville by a majority of 65.

The Borough of Mechanicsburg, Cumberland county, elected a Democratic Burgess by a majority of 2. Last fall the Republican majority in the town was 115.

The Borough of Middletown, Dauphin county, the Democrats elected the whole borough ticket, by an average majority of thirty-five. Last fall Gen. Hartman had thirty-three majority.

A most distressing case of poisoning lately took place near the town of Ligon Grand Rapids, Michigan. It appears that a party of men were employed in the woods getting out pine logs, and they employed a party of men to cook for them. A trapper happened to be at night, and requested permission to remain with them, which was granted. He had with him a paper of strychnine, for the purpose of poisoning in setting his traps for wild animals, and on entering the shanty it was placed on a board shelf carelessly, and left there. The cook, in preparing the meals, took from the shelf, as he supposed, a paper of salt, but instead thereof, poison, and mixed up and baked the biscuit, of which all fourteen partook, from the result of which sixteen persons were poisoned, and died.
