Rivalry of the Parisian Press.

A Paris correspondent of the Washington Republic says, "The Constitutionnel and the Pays have entered upon a dangerous field of rivalry—that of cheap prices. The Pays announced three weeks ago, with immense flourish, a reduction of its subscription from 60 to 40 francs a year, and an increase in its dimensions. This was all the public saw. But behind the curtain a scene had passed which explained the motives of the step. The Pays became the principal government organ; and thus, as Louis Napoleon was interested in its propagation, the secret-service fund was always ready to assist it in case of loss or hard times. The paper had been put at a price which could not pay expenses, for the sake of securing it a universal circulation. As to its being a paying enterprise, for that the Government has no anxiety; it will foot all necessary bills. The Constitutionnel, on the other hand, is a paper that which was done by some people might be done by others, and forthwith diminished its price one-half to 32 francs a year—in the hope of killing off the Pays, and seducing away its subscribers. This is at the rate of two sous a single number, while the Pays and the paper alone costs two sous and a half. The advertising patronage of the Constitutionnel, though enormous, can not repair this serious defect. The probabilities are that the Constitutionnel has been caught napping, that it will itself succumb in the death struggle it meant should be fatal to the Pays."
