State Game Commissioner Kalbfus State Game Commissioner Kalbfus says that at least half a dozen bounty laws, to his personal knowledge, are ready for presentation, and he has every reason to believe that this number will be doubled. The State Game Com mission will not itself have any of these laws introduced, but will the indorsement of the Commission.

the indersement of the Commission.

It is intended to keep the bounties as they are now—\$2 per wildoat, \$1 per fox, 50 cents each per mink or weasel. The purpose of the new law will be to have the present one enforced.

Bounties are now payable by the Commissioners of each county in the Com-monwealth, but it has become a prac-tice for many of these officials to refuse to pay, claiming unconstitutionality of the law. As the claimants of bounties are for the most part men of ex-tremely moderate means they cannot take the case into court. Dr. Kalbfus says, however, that the

law which will be passed will be stringent in its requirement for pay ments of bounties and that any refusal to pay will be met by prompt suit by the Commission itself and an example made as a warning to other would-be recalcitrant officials.
