VARIETIES OF MARBLE.

Their Relativo Value.

The selection of mmble for a monument is altogether a matter of taste. The finent statuary marbles are found in Italy and Greece, but are very expensive, costing from \$15 to \$20 per cubic it would not suit pastors at a disfoot. In the United States good statuary marble has for several years been quarried at West Rutland, Vt., where a layer from three to four feet thick is interstratified with 40 or 50 feet of clouded marble. The finest of statuary marble is found at Pittsford, Vt., where there is a bed 20 feet thick, from which blocks have been taken capable of taking a very fine finish. This marble belt extends north and south of Rutland county, through Vermont and Massachusetts, but in loses in quality in both directions. Toward the north it is finer and harder, but less sound, and toward the south it becomes coarser. Another belt of white marble extends along the flanks of the Alleghanics, through a part of Massachusetts, through New York and Maryland and into Virginia beyond the Potomao river. 


