Son Shoots his Father

The Huntington Globe of the 11th inst. gives the following version of the unfortunate case of a son shooting his father in Huntington. At a few minutes before 7 o'clock, last Friday morning, Henry Meckbaugh, aged about 27 years, shot his father Henry Meckbaugh with a 32-caliber revolver at the home of the wounded man, No. 520 Onida St., the ball penetrating the right breast and lodging in the lung. The affair was the culmination of a drunken debauch by the father, who frequently threatened the members of his family with bodily harm when in an inebriated condition and made their lives miserable.

On the night prior to the unfortunate occurrence, the Senior Meckbaugh was brought home in a maudlin condition by several friends, and he had no sooner entered the house, when he began his usual tactics of threatening to cast the members of the family out of the premises and do them personal injury. The household was in a state of excitement, and he was finally induced to go to bed where he remained until three o'clock, when he awoke and repeated his threats, directing them principally to Henry, whom he said he would shoot. At 7 o'clock while still under the influence of liquor, he repeated the threats when the family was at breakfast and Henry having been keyed to a high pitch of excitement, and fearing that the father would do himself, his mother and others bodily harm, fired the shot which lodged in the father's breast. A second shot was fired accidentally, but Adam, a brother of Henry, parried the revolver, and the ball struck the kitchen stove.

The wounded man was put to bed and Dr. Harmon was summoned, who quickly responded, and for the man in a somewhat critical condition. His rugged constitution, however, is such in his favor and he is gradually recovering. Material improvement is noted every day.

Shortly after the occurrence young Meckbaugh voluntarily resigned himself into the hands of the authorities and proceeded to the county jail. A habeas corpus hearing before the court on Monday afternoon Dr. Harmon having testified that the wounded man was on a fair way to recovery young Meckbaugh was released on bail in the sum of \$800, John Brewster and M. W. Isenberg going his security.
