HIS NAME IS HAYES.

Yes, his name is General Rutherford B. Hayes, and he is from Ohio. He belongs to Grant, Cameron, Morton, Conkling and Co. by right of discovery, and has undoubtedly promised to be bounded by them in his cabinet ministry as the price of their support to secure the nomination. To be more explicit, General Rutherford B. Hayes, of Ohio, was nominated by the administration party at Cincinnati on Friday last, for the office of President of these United States.

Under the present so-called leaders, the art of administration has at once degenerated into mere trickery or management. "Toads have crawled into the seats of eagles." The possession of office has become a badge of imbecility, cunning and insolence; and those delegates in the convention who yesterday succumbed to the authority and trickery of that badge, will bear the stamp of venality and imbecility.

In the first ballot of the Convention, two hundred and eighty-five staunch, reliable delegates, showed that they knew the will of the people and were to be guided thereby. Others also, did their duty in presenting and upholding the names of their respective candidates.

Thus it will be seen that in one ballot the four prominent opposing candidates were dropped and the vote centered on Hayes. Though we are at this time without information in detail, yet enough is known to warrant us in saying that this was the work in the main of Conkling delegation from this state, picked by some other "machine" malcontents, and aided and abetted by the whole force of which the administration was capable.

Although the "machine brigade" have received a stern rebuke by the solid steadfastness of a large vote in the convention, it is without effect, for they are callous to all considerations of honor or decency, and it now behooves the people to take the matter in their own hands, and remedy as far as lies in their power, the existing evil.

The Boston Post makes a point in this forcible language: "When one reads in an acknowledged Republican organ the statement that 'Secretary Cameron and other Pennsylvanians have been busily at work at Cincinnati endeavoring to ratify the contract for the delivery of the state to Conkling,' it is not impertinent to ask what sort of a party is this which unblushingly concedes the fact that its President sells cabinet officers for votes in its convention, and which records without winking the operations of its cabinet officers to 'deliver' the vote of a state according to contract."

There is a conspicuous absence of enthusiasm over the nominations, and a wearisome lack of variety in the comments of the newspapers, as will be seen from the column of comments elsewhere printed. The great advantage of this ticket is that nobody can possibly take offence at it and the Republican papers all take it down easily, though with no great appetite.

The Hon. Wm. A. Wheeler, the Cincinnati nominee for Vice President, represents the Nineteenth district of New York in the present congress. He has had a large and varied experience in public life. He has been a member of both branches of the legislature of New York and for two sessions presiding officer of the state senate.

On the seventh and final ballot at Cincinnati the Pennsylvania delegation split into two nearly equal factions. Thirty-four went to Blaine under the lead of M'Pherson and twenty-four followed Secretary Cameron to Hayes.
