

The Next Congress.

It is somewhat early, says a late North American, to attempt estimating the manner in which the new apportionment, provided by the act of May 22d, 1850, will affect the several States as regards the distribution of Representatives. The act provides that the whole number of members shall be 233, as the entire population of the country is rated at above twenty-three or twenty-three and a half millions, it is computed that the constituency will be, in round numbers, 100,000. Taking this as the basis, and calculating from mixed returns and estimates of population, the apportionment among the States would be somewhat as follows:

Mr. Patterson is a native of New Jersey, and is 51 years of age. — Springfield Republic.

The H. Haysburg Standard of Wednesday last, contains a villainous, but unsuccessfull, attempt made last week to set fire to 50 or 60 wooden cars belonging to the Union Line, and which were standing on the railroad near the warehouse. The villains collected a quantity of shavings and shingles which they placed inside of one of the cars. Underneath these they placed nearly a pound of powder, a train of which they carried to door of the car, which they closed, and applied a slow match. The match however went out, thus providentially frustrating their hellish designs. We have certainly fallen upon evil times when such fiendish attempts as this to destroy the property of our citizens are made in our very midst, and it behooves our people, not only to guard well their property, but to use all their vigilance to detect, and bring to punishment the perpetrators of these villainous outrages.

TARIFF MOVEMENT.—We observe that Mr. Dobbins, the Democratic member of the Legislature from Schuylkill county has introduced the following resolution: Resolved, That our Senators in Congress be instructed, and our Representatives requested, to use their best efforts to procure a modification of the existing Tariff laws, so as more effectually to protect the Iron and Coal interest of this Commonwealth, and also, to advocate a further amendment to the said laws, so that the duties may be levied at home, and not in foreign valuation, and that the Governor be requested to have copies of this resolution forwarded to each Senator and Representative in Congress, now assembled.

JACKSON MONUMENT.—The Committee to whom the subject was referred, at a late meeting in the city of New Orleans, have reported a series of resolutions, recommending that the mayor, the recorders of the municipalities, the members of the Councils, the Mayor and Council of Lafayette, Baton Rouge and other large towns in the State, be appointed general receivers and agents to get subscriptions for the purpose of erecting a monument to General Andrew Jackson, in the Place d'Armes. The resolutions are to be on the 4th of July next. The resolutions were unanimously adopted.

GUBERNOR QUITMAN.—The New Orleans Delta, learns from Jackson, Miss, that Governor Quitman will promptly and cheerfully obey the process of the United States Court for his appearance on the charge of being engaged in the Lopez expedition. It is said that Judge Gholsen has delayed issuing the writ of arrest to allow Governor Q. to dispose of the business of his office, so as to leave Jackson without too much prejudice to the public interest confided to him.
