IMPORTANT FROM CHINA.

Latest from China—Blowing up and destruction of the Chinese villages and probable destruction of Canton, &c.

The Brig ALBION arrived at this port yesterday from Canton which place she left on the 15th of September. She has a full cargo of Teas and Silks consigned to Boorman, Johnston, & Co. It was said by the Chinese that among was taken and burnt by the British on the 27th Aug. From Canton there is intelligence of interest contained in the following extract of a letter dated,

MACAO, 8 1/2 o'clock, P. M., 15th Sept. 1841. I have already written to you several letters by this conveyance which I now confirm, and have now just heard, I hope in time for this vessel, of Capt. Nias (the commanding officer) having issued a proclamation in Chinese, and commenced hostilities by attacking the villages on the banks of the river near where the obstructions were sunk, and by blowing up and utterly destroying Wong Tung and the fortresses at Cow Loon. There is a rumor of his intention to surround Canton, and I should not be much surprised to hear of the city being burnt before I get away from here. Thus it appears, as conjectured and stated to you yesterday, that the least provocation is now made the excuse for great violence, and the result is as doubtful, and the anticipation of it as much clouded by a fear of suffering to the innocent people, as at any former period. This news is just at hand in a letter from Canton, when the smoke of the burning villages was seen, the cannons heard, and the people of Canton were fleeing in all directions, whilst the reports were that many people had been killed at the villages.

Colt, the Suspected Murderer.

We are indebted to the New York Tribune for an extra, giving the particulars of the trial of John C. Colt, charged with the murder of Samuel Adams. The prisoner was without gloves, was dressed in a frock coat of blue beaver cloth with a velvet collar, his hair was well brushed, his whiskers neatly trimmed, and he appears to have suffered scarcely at all, either from his confinement or from the reactions his condition must naturally awake

within his breast. His face was slightly flushed, and there came at times across his strongly marked features, a bitter, scornful expression, which soon disappeared, however, and he again resumed his wonted composure, occasionally gazing intently upon vacancy, he seemed deeply absorbed in reflection. When addressed by those around him, he conversed with easy familiarity, and occasionally with vivacity and cheerfulness. His brother, the inventor of the patent rifles, was present and seated by his side; and among the witnesses was Mrs. Adams, the widow of the deceased, attended by her father. The Court finding it difficult to obtain a Jury, determined to summon three hundred persons to attend on Wednesday, and adjourned.

HARRISBURG NEWS.

January 20, 1842.

In Senate.—Mr. Fegely read in his place a bill supplementary to the act incorporating the German Lutheran congregation in the borough of Reading, Berks county.

Mr. Ewing offered resolution requiring the Auditor General to furnish a statement of the amount of taxes to be received by the State, in accordance with the acts of 1840 and '41. Agreed to.

Mr. Bigler a resolution for the purchase of ten copies of the edition of Purden's Digest, for the use of the Senate, which was adopted.

The Senate then taking up executive business, the nomination of Joseph Engles was postponed until Tuesday next. The following nominations were then confirmed by a vote of yeas, 29—nays, none on each.

John K. Findlay, as Recorder for the city of Lancaster.

John Shaffer, Associate Judge of Centre county. Benjamin Lathrop, Associate Judge of Susquehanna county.

Samuel P. Silley, Associate Judge of Mifflin county.

The nomination of Molton C. Rodgers as Associate Judge of the Supreme Court will, I hardly think, be confirmed. A number of the friends of the Governor are kicking against it most wonderfully, and strange as it may be, the Whigs are the advocates of his confirmation. The rotary principle will be brought to bear against him, and from present appearances, unless the Governor is stubborn, he will find that the doctrine which has been preached so long, will be in his case reduced to practice. I cannot, for my part, understand the opposition to this nomination, unless there is another candidate who is to be favored by it.

Who that candidate is, I am unable to conjecture, unless it should be a particular friend of the Governor's in the Lehigh and Northampton districts.

In the House.—After the presentation of an unusually large number of petitions,

Mr. Brodhead offered a resolution for the appointment of a select committee to make a personal examination of the line of the Erie Extension, and make report to the House at the earliest possible period, of the probable cost of completing said line, as also the amount required, should the work be immediately suspended, said committee having power to examine under oath, any persons, relative to the subject.

After much debate, the resolution was negatived.

Mr. Futey submitted a resolution instructing the committee on the judiciary to inquire into the expediency of providing by law for securing all property, real and personal, to females who may be divorced, which belonged to them originally, whether hereditary or otherwise.

Mr. Sharswood submitted a resolution instructing the committee on ways and means to inquire into the expediency of repealing the 6th section of the act of 23d April, 1841, relating to retailers of foreign wines and merchandise.

Mr. Roomfort submitted a resolution instructing same committee to inquire into the expediency of leasing to individuals, for a term of years, the Delaware Division, and also the main line of improvements from Philadelphia to Pittsburg.

The House took up and finally passed the bill relating to the prison in Chester county.

NEW KIND OF TAXATION.—It is proposed in the Legislature of Indiana, to lay a tax on lawyers, doctors, old bachelors, and old maids. If some of the advanced ladies should ever meet the ungallant member who made the proposition, he would be likely to wish he had never been sent to the Legislature.
