That some time in the latter part of May, or first of June, 1848, a man by the name of Jacob Townsend, who at that time was a book and pamphlet peddler, called upon deponent, at the house of Mr. Thompson, No. 42 Hudson street, where deponent boarded, and requested deponent to write him a recipe by which to make a Syrup of Sarsaparilla. Deponent further says, that he became acquainted with said Townsend at the office of Theodore Foster, Faq., Book Publisher, with whom said Townsend dealt That said Townsen I had had frequent conversations with deponent respecting the manufacture of an article of Sarsaparilla to be sold under the name of Dr.

Jacob Townsend. 
