

and monopolist, may ever continue so, and may become the happy homes of the virtuous and patriotic sons of freedom.—Give to the poor and friendless among us a home which will not impoverish us, but which will make them rich indeed; and although the benefits arising from it may not at once be felt throughout our country—though society may not immediately reap the rich harvest of reward which must ultimately be realized from such an act of mercy, depend upon it, the seed will thus be sown, from which, if we do not, our children at least may reap the fruits of a rich and abundant harvest."

The measure, we repeat, is one of the utmost importance, and we shall watch its progress in the Senate with the keenest anxiety. Its final adoption would open a new era in the history of this country.

### The Work goes on.

On Monday the 24th ult., an alleged fugitive slave was arrested in Harrisburg tried before Commissioner McAllister and sent into slavery. The State Journal gives the following account of the transaction.

"An alleged fugitive slave, named James Phillips, was arrested in this place on Monday last, by Deputy Marshals Loyer and John Sanders. Phillips has resided in Harrisburg for the last ten or twelve years, is an honest, industrious man, and has a wife and several children. His arrest caused the most intense excitement; and during the examination, which lasted three or four hours immense crowds of people surrounded the office of the Slave Commissioner, all anxious to learn the fate of poor Phillips. After hearing the testimony which, *tous, nearly no means conclusive as to the identity of the alleged fugitive*, he was surrendered to the claimants, who with great difficulty, and after a desperate struggle, succeeded in ironing him. During the struggle in the office between the captors and the captive, the "outsiders," moved by the frantic and heart touching cries of the poor wife thus rudely torn from her husband and the father of her little children, became greatly excited, and were unspurring in their denunciations of the Slave Commissioner and his deputies. At one time, indeed, so intense was the excitement, that we feared an attack upon the Commissioner's office. Order was speedily restored, however, and Phillips, without being permitted even to see, and bid his wife a "last, long farewell," was hurried off to prison, and the wretched mother returned to her desolate home, with a sorrowful heart, to comfort, as she best might the little ones thus suddenly deprived of the protection of a kind and provident father. The scene was one calculated to excite deep sympathy, and to melt the hardest heart."

Dr. Birdsell called in Dr. Mulford, one of our oldest and most experienced physicians, who coincided with the above treatment, and pronounced it the best developed case of lock-jaw from the beginning, he ever met with.—Mr. Githens is now sitting up, free from all the symptoms, which lasted about four weeks. A cure of this disease may be considered one of the wonders of the age; and the fact that it was successfully treated reflects the highest credit upon the professional attainments of Drs. Birdsell and Mulford."

### The Difference.

When Mr. Gorsuch, of Maryland, was murdered at Christians, in Lancaster county, last fall, every body remembers what an uproar the Loco-focos made—how they abused Gov. Johnston, and how severely they blamed him because he did not assume the functions of a police officer, and go in person to the scene to gaze on the mangled corpse of the cruelly slain man, and take measures for the arrest of the perpetrators of the crime. Well, a man—of an unpopular color, to be sure—but still a sort of a man, whom it would be murder for a nigger at least to kill—has been shot dead at Columbia by a Marylander, a white person to be sure; Gov. Bigler has not gone to the place to see the corpse—has not offered a reward for the absconding doer of the deed—has not made a requisition for his surrender on the Governor of Maryland;—has done nothing, in fact, in the case, any more than if a dog had been killed. No political capital can be made out of a dead nigger, no Southern votes can be conciliated by demanding the surrender and trial of the alleged murderer—no *humbung* about the Compromise and Danger to the Republic.

DEMAND FOR LAND WARRANTS AT CINCINNATI.—There has been considerable demand for Warrants at Cincinnati, for the last ten days. The Gazette says that brokers are giving \$127 for 160 acres warrants; \$65 for 80 acres, and \$32 50 for 40 acres. Sales at \$135 for 160 acres; \$70 for 80 acres, and \$37 50 for 40 acre warrants.

A woman has been arrested in New York and committed for trial, for her extravagance in having two husbands when many worthy ladies cannot get one.
