### AMENDMENT TO THE CONSTITUTION

Proposed to the citizens of this Commonwealth by the General Assembly of the Commonwealth of Pennsylvania.

### AMENDMENT

Strike out from section one of article eight the four qualifications for voters which reads as follows:

### AMENDMENT

If twenty-two years of age or upwards, he shall have paid the taxes on his real estate and county tax, which shall have been assessed at least one month before the election.

### AMENDMENT

Every male citizen, twenty-one years of age, possessing the following qualifications, shall be entitled to vote at all elections.

### AMENDMENT

Second: He shall have resided in the state one year or if having previously been a qualified elector or native born citizen of the state, he shall have resided therefor and returned (six months) immediately preceding the election.

### AMENDMENT

Third: He shall have resided in the election district where he shall vote for at least two months immediately preceding the election.

### AMENDMENT

Fourth: Every male citizen of the age of twenty-two years, who shall have been a citizen of this state one year next preceding the election, shall be entitled to vote at the election.

### AMENDMENT

Fifth: For the purpose of voting, no person shall be deemed to have been a citizen of this state by reason of his presence or absence while employed in the army or navy thereof.

### AMENDMENT

Sixth: The legislature at the election district where he shall vote for at least two months immediately preceding the election.

Seventh: For the purpose of voting, no person shall be deemed to have been a citizen of this state by reason of his presence or absence while employed in the army or navy thereof.
