### CONSTITUTION OF THE COMMONWEALTH OF PENNSYLVANIA.

ARTICLE I. The legislative power of this Commonwealth shall be vested in a General Assembly, which shall consist of a Senate and House of Representatives.

Section I. The representatives shall be chosen annually by the citizens of the city of Philadelphia and of each county respectively on the second Tuesday of October.

Section II. No person shall be a representative who shall not have attained the age of twenty-one years, and have been a citizen and inhabitant of the State three years next preceding his election.

Section III. The number of Senators shall be not more than thirty, and not less than twenty, and shall be chosen for three years.

Section IV. The number of Representatives shall be not more than ninety, and not less than sixty, and shall be chosen for two years.

Section V. The Governor shall be chosen for four years, and shall be eligible for a second term.

Section VI. The Governor shall have the honor and command in chief of the Army and Navy of this Commonwealth.

Section VII. The Governor shall have the power to pardon and reprieve all crimes and offenses, except in cases of impeachment.

Section VIII. The Governor shall have the power to appoint and remove all officers and ministers of the State.

Section IX. The Governor shall have the power to grant reprieves and pardons, except in cases of impeachment.
