

The election of members of the Legislature, &c. took place in the State of New York on Tuesday the 7th inst. in the City of New York...

So far as heard from, through the State, the Whigs have gained, Schenectady county, all Whigs last year, 243 local. Montgomery, nearly all Whigs last year 613 local. Albany 400 Whigs last year 800. Orange 500 Whigs gain since last year. Westchester Whig, the first time for many years. Columbia 700 Whig gain. Partial returns have been heard from a number of counties but enough is not yet ascertained to form an opinion as to the general result. The local majority was so large last year, that we doubt whether the Whigs can overcome it. There is no doubt, however, it will be very much reduced.
