TERMINATION OF THE WAR IN INDIA — Since the despatch of our paper by the "Unicorn," our adv cas from Bombay inform of two more great ba les having been fought in India be-tween the British and Sikh armies, both ern inating in decisive victory to the former. The first was under the command of Sir H. Smith, and the latter Sir Hugh Gough, which was perhaps one of the most bloody on record. In Sir H. Smith's hatter, he whole are y of the enemy was driven headlong o er the difficult ford of a broad river; his camp, cainon, (56 pieces.) baggage, stores of ammu-nition and of grain—his all, in fact, wrested non, (b) pietes;) organinginger into the view of the form him by the repeated charges of caval y and infantry; and in that of Sir Hugh Gough's, the Sikhs lost 12,000 men, and 65 pieces of artillery. The English had 300 men killed, 13 of whom were officiers, and 2500 wonded, of whom 101 were officers. Her Majes

ty's 53d and 62d regiments suffered enor-mously. General Dicke and Brigadier Tayamong the dead.

The European Times says: "The severe thrashing of the Sikh forces by Sir H. Smith, has been consummated, by the total defeat of the main body by the Governor General o. India and the Commander in-Chief. The loss of the enemy in this engagement is estimated at from 10,000 to 12, 600 men; that of the British in killed and wounded at upwards of 2000, amongst which is a large portion of officers. The action. commenced in the moning, and the work of destruction had closed by eleven o clock in the forenoon. Sir Hugh Gough's account of this battle proves it to have been, while it lasted, one of the most terrific on record. Un-like the able manœuvring of Sir H. Smith. this allair seems to have owed its success to the daring intrepidity of our men, who stormed the enemy's intrenchments, bayonet in hand, defended as they were, by 30,000 Sikhs and To pieces of artillery. The slaughter was immense, for our troop

braved the enemy's fire by reserving their shot until they got within their entrenchme. t-r The horrors of war are painted with appaling power in the few brief sentences of the victo-rious commander. For the details we must refer the reader to the despatch itself. It is a document that will amply repay perusal. The action terminated in the complete route of the enemy, the capture of his guns, and the loss of his camp and baggage. An awful savrifice of life took place on the Sukej, in attempting to cross which, our troops mowed down thousands of the flying foe, and those who escap-ed the fire were drowned in the stream. This
