AUGUST COURT.

The Courts of Quarter Sessions and of Oyer and Terminer for Lumberland County-IIon. F. WATTS, Fresident, and Associates, Judges STUART, and CLENDENIN, on the Bench -opened on Monday the 27th ult. There was an unusually large amount of business, which was disposed of in a very rapid manner, by the energetic action of the Court, and the promptness of the Prosecuting Attorney, JAMES R. SMITH, ESQ. Much of the business was however laid over until the next Court, on account principally of defendants against whom bills were found by the Grand Jury, not having been arrested.
