RESOLUTION PROPOSING AMENDMENTS TO THE CONSTITUTION OF THE COMMONWEALTH.

Resolved by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, That the following amendments are proposed to the Constitution of the Commonwealth, in accordance with the provisions of the tenth article thereof.

There shall be an additional article to said Constitution to be designated as ARTICLE XXI: SECTION 1. The State may contract debts, to supply casual deficits or failures in revenues, or to meet expenses not otherwise provided for, but the aggregate amount of such debts direct or contingent, when contracted, shall not exceed the sum of one million dollars, and shall not be incurred for any other purpose than the contracting of such debts, and shall be applied to the purpose for which it was contracted, or to the discharge of the same, and no other purpose whatever.

SECTION 2. In addition to the above limited power, this State may contract debts to repel invasion, suppress insurrection, defend the State in war, or to redress the wrongs of the people, and the amount of such debts shall be applied to the purpose for which it was raised, or to repay such debts, and to no other purpose whatever.

SECTION 3. In addition to the above limited power, this State may contract debts to repel invasion, suppress insurrection, defend the State in war, or to redress the wrongs of the people, and the amount of such debts shall be applied to the purpose for which it was raised, or to repay such debts, and to no other purpose whatever.

SECTION 4. To provide for the payment of the present debt, and by additional debt, contracted as aforesaid, the Legislature, at its first session, after the adoption of this amendment, create a sinking fund, which shall be sufficient to pay the accruing interest on such debt, and annually to reduce the principal thereof by a sum not less than two hundred and fifty thousand dollars, until the principal of the debt shall be paid in full, or until the annual income of the public works, from time to time owned by the State, or the proceeds of the sale of the same, or any part thereof, and of the income or proceeds of sales of stocks owned by the State, together with other moneys, or resources, that may be designated by law. The said sinking fund may be increased, from time to time, by assigning to it any part of the taxes, or other revenues of the State, not required for the ordinary and current expenses of government, and unless in case of war, insurrection, or rebellion, no part of the said sinking fund shall be used or applied otherwise than in the extinguishment of the public debt, until the amount of such debt is reduced below the sum of five millions of dollars.

SECTION 5. The credit of the Commonwealth shall not in any manner be pledged, or loaned to, any individual, company, corporation, or association, in or for the commonwealth hereafter become a joint owner or stockholder, in any company, association, or corporation.

SECTION 6. The Commonwealth shall not assume the debt, or any part thereof, of any county, city, borough, or township, or of any corporation or association, unless such debt shall have been contracted to enable the State to repel invasion, suppress domestic insurrection, defend the State in war, or to assist the State in the discharge of any portion of its present indebtedness.

SECTION 7. The Legislature shall not authorize any county, city, borough, township, or incorporated district, by virtue of a vote of its citizens, or otherwise, to become a stockholder in any company, association, or corporation, or to obtain money, or loan its credit, in any corporation, association, institution, or party.

SECTION 8. There shall be an additional article to said Constitution, to be designated as article XXII, to-wit: ARTICLE XXII. No county shall have the power to alter, revoke, or annul, any charter of incorporation hereafter conferred by, or under, any special or general law, whenever in their opinion it may be injurious to the citizens of the county, or to such number, however, that no injustice shall be done to the corporators.
