#### Old Virginny in a Stew.

The Hon. John M. Botts, of Virginia, is anther noble Southern man, who like Judge Bates, of Missouri, Senator Bull, of Tennesee, Hon. Henry Winter Davis, of Baltimore, d. ad other true Southern patriots, dares to ay in plain language that the election of Eremont will not dissolve the Union. - In a speech ecently delivered at Richmond, Virginia, he concludes na follows :

"With regard to the frequent threats of disunion, let me say that the Union is in no anger of a dissolution. There are but two -ways of dissolving the Union: one is by revoution and force, which the strong arm of the general government will always be able to put down; and the other is by a convention of the States that adopted the constitution, and framed the government of their choice. Newspaper editors and cross road politicians have no power to dissolve it, and there is now and always will be, good sense enough amongthe conservative elements of the country now engaged in their daily avocations in the field, in the workshop, in the factories, and in every pursuit of life, not heeding nor caring for the cry of 'wolf! wolf!' with which our ears have become familiarized, but who will, when occasion calls for it, rise up in their mighty strength and trample under foot these noisy mischievous malcontents, who make inight hideous with their yells of disunion; and let me tell them that 'I will meet them at Phillippi,' and on that field they will find me kneeling at no other altar than the altar of the Union, worshipping at no other shrine than the shrine of the constitution, and fighting under no other flag than the stars and stripes of the United States."

For the utterance of these noble sentiments the Richmond Enquirer, and its democratic cotemporaries in Virginia, are doing the best they can to stir up a mob against John Minor Botts for daring to say in Richmond that the The N. Y. Herald says that these democratic ninnies are scratching, and kicking and biting and snorting over this declaration like a pack of veritable jacknesses afflicted with the botts. Mr. Pryor calls upon his fellow citizens to expel Botts, to ostracise Butts, to export Botts to the North, to drive Botts out of the State forthwith; in fact, Master Pryor would think t none too good for Botts, if Brooks were to come suddenly upon him and maul him over the head within an inch of his life; or if the infuriate ruffians of the secession democracy were to bang, draw and quarier Botts, and roast him and cat him, blood, body, and banes.

... NEWS FROM CENTRAL AMERICA. -- By the arrival of the Tennesse at New York we receive interesting news from Nicaragua and Costa Rica. The tide is represented as having again turned in Walker's favor. His army well organized and in good health and spirits, consisted of about 1,600 Americans. A couple of hard fought skirmishes had taken place at San Jacinto, where a body of the adherents of Rivas had fortified themselves in a ranche .-Two attempts to dislodge them proved unsuc cessful, and the Government troops were com pelled to retire with considerable loss. Rivas. as a political leader, is said to be extinguished. He still retains possession of leon, but his men are dying daily from starvation and cholera. From Costa Rica we learn that the soldiers are epposed to another invasion of Nio-aragua, but declared their readiness to defend their own country if required. We receive no confirmation of the rumor that Costa Rica had concluded a treaty with Nicaragua. MENDMENTS TO THE CONSTITUTION OF

Resolved by the Sonate and House of Representatives of the Commonnealth of Pounsylvania in General Assembly met. That the following amendments are, roposed to the Constitution of the Commonwealth, in accordance with the provisions of the tenth article FIRST AMENDMENT.

There shall be an additional article to said Consiltution to be designated as Anticle XI.

OF PUBLIC DEBTS.

Section 1. The State may contract dobts, to supply asual deficits or fallures in revenites, or to meet expenses not otherwise provided for; but the aggregate amount of such debts direct or contingent, whether contracted by virtue of one or more Acts of the General Assembly, or at different periods of time, shall never exceed seven hundred and fifty thousand dollars, and the illney arising from the creation of such debts, shall the applied to the purpose for which it was obtained, or to repay the debts so contracted, and to no other purpose whatever.

Section 2. In addition to the above limited power the State may contract debts to repel invasion, sup-press insurrection, defend the State in war, or to re-deem the present outstanding indebtedness of the state; but the money arising from the contracting of such debts, shall be applied to the purpose for which it was raised, or to repay such debts, and to no other purpose whatever.

SECTION 3. Except the debts above specified, in sections one and two of this Article, no debt whatever shall be created by or on behalf of the State.

SECTION 4. To provide for the payment of the present debt, and any additional debt, contracted as aforesaid, the Legislature shall, at its first session, after the adoption of this amendment, create a sinking fund, which shall be sufficient to pay the accruing interest on such debt, and annually to reduce the principal thereof by a sum not less than two hundred and fifty thousand dellars; which shaking fund shall consist of the net annual income of the public works, from time to time owned by the State, or the proceeds of the sale of the same, or any part thereof, and of the income or proceeds of sales of stocks owned by the State, together with other funds, or resources, that may be designed by law. The said sinking fund may be increased, from time to time, by assigning to it any part of the taxes, or other revenues of the State, not required for the ordinary and current expenses of government, and unless hi case of war, insurrection or invasion, no part of the said sinking fund shall be used or applied otherwise than in the extinguishment of the public debt, until the amount of such debt is reduced below the sum of five millions of dellars.

Section 5. The credit of the Commonwealth shall not in any minner, or event, be piedged, or loaned to, any is coacea occow the sum of the millions of dollars. It Section 5. The credit of the Commonwealth shall not in any manner, or event, be pledged, or loaned to, any individual, company corporation, or association; nor shall the commonwealth hereafter become a joint owner or stockholder, in any company, association, or corporation.

Sec. 6.-The commonwealth shall not assume the debt, or any part thereof, of any county, city, borough, or township; or of any corporation or association; unless such debt shall have been contracted to enable the state to repel invasion, suppress domestic insurrection, defend itself in time of war, or to assist the state in the discharge of any portion of its present includedness.

The Legislature shall not authorize any county, city, borough, township, or incorporated dis trict, by virtue of a vote of its citizens, or otherwise, to become a stockholder in any company, association, or corporation; or to obtain money for, or loan its credit to; any corporation, association, institution, or party.

The legislature shall have the power to alter, revoke, or annul, any charter of incorporation hereafter conferred by, or under, any special or general law, whenever for their opinion it may be injurious to the citizens of the commonwealth: in such manner, however, that no injustice shall be done to the corporators.


