THE NEW ADMINISTRATION.

Mr. Buchanan was to leave Wheatland for Washington on Monday, and we hope arrived there safely. The rush of visiters to the inauguration, which takes place to-day, has been immense, and the demonstration promises to be of the most imposing character. The last rumor in respect to Pennsylvania's representation in the Cabinet is that Arnold Plumer, of Venango county now in the board of Canal Commissioners, has been selected as Post Master General.

DEMOCRATIC CANDIDATES.

We learn from Harrisburg that the democratic nominees for the next campaign, as fixed by the State Convention lows :-- For Governor, William F. Pack er, of Lycoming county; Judge of the Supreme Court, Ellis Lewis, one of the present Court; / Canal Commissioner Nimrod Strickland, of Chester County. The proceedings of the Convention were warm and exciting. Ool. J. W. Forney was present and delivered an ac dress at the opening. He made a very delicate allusion to the election of U.S. Senator, saying that not withstanding the great democratic triumph in the Presidential election, the usages of the party had since been violated and their tri umph was suffered to rot away under their feet. After a stormy debate. James M. Anderson was rejected as a delegate from York, under the allegation that. he influenced Mencar to vote for Gen. Cameron. The ballotings for Governor amounted to near fourty and Packer at last succeeded over Black and Witte, by a majority of one or two. Cumberland County's candidate for the Supreme Bench was again " sot back," and Judge Lewis who didn't want the nomination got it, as of course he knew he would. The Union State Convention will meet on the 25th inst., when if a judicious se lection of candidates is made, we may enter the field with a fair prospect of success. UNION OF THE OPPOSITION .--- The Opposition look forward to the meeting of the Republican State Convention, at Harrisburg, on the 25th of March, with deep interest. - The Lehigh Register says quite a number of names have been suggested by the press in different sections for the various offices, and from their tone we are led to believe that both Republicans and Americans, are agreed to overlook the distinctive features of their respective organizations, and go for the men who will be best able to cope with and overpower the sham Democracy.
