

**A Joint Resolution Proposing**  
CERTAIN AMENDMENTS TO THE CONSTITUTION

Whenever any of the qualified electors of this Commonwealth shall be in any actual military or naval service, or in the service of the United States, or by the authority of this Commonwealth, such electors may exercise the right of franchise in all elections by the citizens, under such regulations as may be prescribed by law, as fully as if they were present in person at the polls.
