CLEAN THE BARK OF FAULT TREES -The mild days of this month will answer for this purpose. Apple and pear trees are frequently infested with bark lice of several varieties .--They are found not only on the trunk and large limbs, but upon the twigs nicely glued on around the buds, ready to take advantage of the first appearance of the tender leaves .--After the foliage has started, it is difficult to remove them without destroying many of the buds and leaves.
