monwealth, and that no Inspector, or Judge, or other officer of any such election shall be eligible to any office then to be voted for. Also, in the 4th section of the Act of Assembly, entitled "An Act relating to elections and for other purposes," approved the 10th day of April, 1856, it is en acted that the foregoing 18th section shall not be so construed as to prevent any military officer or borough officer from serving as Judge or Inspec-

tor at any general or special elections in the Commonwealth

Also, that in the 61st section of said Act it enacted that "every general and Special Election shall be opened between the hours of eight and ten o'clock in the forenoon, and shall continue without interruption or adjournment, until seven o'clock in the evening, when the polls shall be closed.

The general, special, city, incorporated district, and township elections, and all elections for electors of President or Vice President of the U.S. shall be held and conducted by the Inspectors and Judges elected as aforesaid, and by clerks appointed as hereinafter provided.

No person shall be permitted to vote at any election, as aforesaid, but a white freeman of the age of twenty-one years or more, who shall have resided in this State at least one year, and in the election district where he offers to vote at least of the County of Cambria, in the Commonwealth ten days immediately preceding such election, and within two years paid a State or County tax which shall have been assessed at least ten days a GENERAL ELECTION will be held in the before the election. 




