A PROCLAMATION.

To sustain the Government in times of common peril by all his energies, his means and his life, if need be, is the just duty of every loyal citizen. The President of the United States has made a requisition on Pennsylvania for twentyone new regiments and the regiments already in the field must be recruited.

Enlistments will be made for nine months in the new regiments, and for twelve months in the old. The existence of the present emergency is well understood. No patriot will pause now to in-

That as to both property and persons of African descent accounts shall be kept sufficiently accurate and in detail to show the quantities and amounts, and from whom both property and such persons shall have come, as a basis upon which compensation can be made in proper cases. The several departments of this government will attend to and perform their appropriate parts towards the execution of these orders.




