therefore, I, Abraham Lincoln, President of the United States, do hereby make known to all whom it may concern, that the privilege of the writ of Habeas Corpus is suspended throughout the United States, in the several cases mentioned, and that this suspension shall continue throughout the duration of the rebellion, or until this proclamation is rescinded, or until this proclamation is superseded by a subsequent one, to be issued by the President of the United States, be modified or annulled. And I do hereby require all military and naval service by authority of the President of the United States, or for any other purpose of the military or naval service.
