He said his opinion on the subject of popular sovereignty had undergone no change, but that the conduct of the people of the border counties of Missouri had astounded and amazed him by their reckless disregard of all laws, compacts and constitutions. That the territory of Kansas in her late election had been invaded by a regular organized company armed to the teeth, who took possession of their ballot boxes and made a Legislature to suit the purposes of the pro-slavery party. Kansas was subdued and conquered by armed men from Missouri, but her citizens were resolved never to give an the fight for their freedom and the independence of their soil from foreign control or inter-
