

She accompanied her to St. Paul. She was, of course, distressed. In less than five hours from the time of her arrival, the general people of that city subscribed the sum of one hundred dollars for her relief. The ladies of St. Paul treated her with the greatest attention and kindness, and everything will be done for her at Silver Lake. The two ladies who rescued Mrs. Marble were paid the sum of five hundred dollars each.

On the 24th of May a party of trusty Sioux from the Last of June expedition, left the Yellow Medicine, under the direction of Mr. Flindran, to reason if possible the remaining captives. They were furnished with the following outfit: 4 horses, 1 double wagon and harness, 12 pair of blankets, 4 blue and 8 white, 22 yards of blue square cloth, 87 1/2 yards square cloth, 20 pounds of tobacco, 1 sack of shot, 13 shovels, several rolls of ribbon, 50 pounds of powder, 1 sack of corn, 1 sack of flour, 2 pieces of pork, some coffee and sugar.

The two extra horses, the blankets and other goods were to be used in the purchase of the goods from the Indians; the provisions were for the sustenance of the party. Mr. Flindran charged the Indians positively to let no obstacle discourage them, or to do anything to turn back; to exercise their best judgment in negotiating for the release of the prisoners; but to give everything they had rather than to fail. They would have to travel 125 miles to reach the place where Mrs. Marble was found. They are expected to have to follow the trail of the Indians, and that for several days, as the guilty band had not constantly changed their position. Ten days or two weeks probably will be employed in accomplishing the journey and back.

The government has ordered six companies of the 10th Infantry, now stationed at Fort Snelling, to go out into the Sioux country, against the lower band of Daotah Sioux, at Spirit Lake and Red Moon; also, among the Jiquis River Indians. The theory of the government is, that the predominantly friendly Indians are a silent party to the outrage committed March, and they will in future be held responsible for the conduct of their renegades.

Col. W. H. Noble's Pacific wagon road party—a splendid company of about eighty men, well equipped—were about to start from St. Paul, where they have been waiting for several weeks, at an expense of three hundred dollars per day, for the War Department to forward their arms—will go through the country inhabited by the outlaw Sioux, and if they meet them, will surely bring them to their camp.

A letter from St. Paul dated 20th ult., says the two surviving captives, Mrs. Noble and Miss Gardner, have been ransomed by friendly Indians, and will soon return in safety to their friends.

From an account in the St. Paul Times we make the following extract: "Although they had abundance of horses at the first the white women were obliged to carry loads from the beginning. Mrs. M., during all her captivity with Red End's people, was nearly two months, and had a bundle of more than one hundred pounds. In this burdened manner, they had to make their way through deep snow and to wade streams of open waist deep, breathing and pushing the ice before them. When they slipped and fell down, they were helped up by a loaded gun pointed at them. Their captives' business was to clear away the snow out their poles, set up the lodge, get the firewood; in a word, to do the drudgery of the camp.

While there was plenty of food which they had taken from the white people, their poor captives had a share. But this did not continue long. The ducks came not back. The grass grew not. The American horses, which they had taken to the number of forty or more, could not eat snow, and consequently died or were killed, and so made food for the company. But even the horse and cow came to an end, and although they could shoot some deer, the Convention refused to go to hunt, and food became so scarce that our American women were glad to get bones and even feathers to roast, and thereby somewhat satisfy the cravings of hunger. When the ground had thawed they dug and ate stick-birds. Mrs. Marble thought she fared better in regard to food than the other women, for the man who kept her did sometimes give her a little, but she adds: 'I would not be willing to tell any one what I had to eat.' The long spring to us was an angle that they expected to see troops coming to their rescue, but they came not; and hope deferred made the heart sick."

ANOTHER FLEMING ANGEL FALLEN.—At the term just closed of the Court of Common Pleas of Carroll county, a trial was had between Elias both Sharp, plaintiff, and Rev. Joseph Barkly defendant, action for breach of marriage contract. The defendant also was one of the Convention men known striking preachers of Carroll county. The evidence on the trial showed that he had for some time been paying his address to Miss Sharp, an accomplished and highly respectable young woman of the county, that he promised to marry her, and then with the helms' machinations of a fiend, but abided with the Every of Heaven, he set about his work of destruction, and by prayers and great professions had righteousness and the Convention's policies.
