

HUNTINGDON FEMALE SEMINARY.

This Institution is now opened under the direction of Miss Levantia L. Phillips, whose recommendations are highly reputable. The number of Pupils already admitted is nearly as large as can be instructed conveniently by one teacher. The Institution is incorporated by act of the Legislature, and provision is made, in part, for payment of the salary of one teacher, or more if the number of pupils should be such as to require an assistant. It will be expected that applicants for admission are sufficiently acquainted with the rudiments of the English language, to enter on the study of Grammar, Geography, &c.; no others will be received.

The following branches, in addition to the common course of studies, will be taught in the Seminary, viz: the French language, Drawing, Mathematics, Chemistry, Botany, Astronomy, Rhetoric, History, Natural and Mental Philosophy.

The price of tuition for the present quarter is two dollars and fifty cents; the additional sum of fifty cents, to be paid by each pupil in advance, is required to defray incidental expenses. If any further sum should be wanted for that purpose due notice thereof will be given. Application for admission must in all cases be made to the officers of the Board, who will submit the same to the Trustees of the Institution for examination and decision. It is desired that pupils enter at the commencement of a quarter, or as soon afterwards as practicable.
