A correspondent of the American Ag-riculturist says: "As I hear much said about the scab in sheep, I send you an ac-count of the treatment of that disease in

a flock of about two hundred, in 1834, that belonged to my father in New Hamp-shire. The flock had been diseased two

that belonged to my father in New Hamp-shire. The flock had been diseased two years, and several remedies had been tried and failed. Many sheep died, and but few ewes raised their young. The cure was this: a decoction of tobacco and sulphur; ten pounds of good tobacco for one hun-dred sheep, well mashed and steeped in about sixteen gailons of water, to which was added one pound of sulphur. "Each sheep was taken and gut upon a bench or form so fixed as to save. the drippings of liquor from the washing, and rabbed, with a hand-swab, made of some kind of cloth, wet in the decoction, being careful to moistefic every part of the neck and body of the sheep. This was done immediate-ly after shearing. The Jamba also under-was made a little weaker for them. The third day after washing; the sheep were, salted with common salt, wet, and as much sulphur stirred in as would stick, to the salt. The flock from this time began from the same sheep were one third heav-ier, and the lambs were healthy, and such seemed to be the benefit derived from the use of tobacco and sulphur, thit if thea-been continued to this time, only the de-coction is made weaker. 
