It shall be the duty of the Secretary of the Commonwealth, to transmit a copy of this act to the Commissioners of each county in the State, who, on receipt of the same, shall publish it, at the expense of the county, at least once a week, for six successive weeks, in two or more newspapers, printed in the said county; and the Sheriff of each county, in the proclamation to be by him published of the holding of the next general election, shall give notice, that votes will be given for or against the calling of a Convention, as aforesaid.
