





All officers whose fees are by this act, and by the act, entitled, "An act establishing a feo bill," passed the twenty-eighth March, eighteen hunired and fourteen, ascertained, limited and apointed, shall and are hereby required to make ir tables of their respective 'ces according to the aid acts, and to publish and keep up the same in their respective offices within six months afor the passing of this act, in some conspicuous have business in said offices; and if any such officer shall neglect to publish and keep up a table of the fees of his office as aforesaid, in such case. such officer shall pay to any person aggrieved the out of TEN DOLLARS, together with double the amount of the excess of fees, if any, which such person may have paid to the said officer, to be recovered with costs of suit by action of debt, in the same manner as other debts are by law recov-
