# **ASSESSMENTS FOR 1846.**

N pursuance of the Act of Assembly passed the 27th day of July 1842, the following statement is hereby published by the Commissioners of Adams County, which exhibits the amount, description and value of the real and personal property, trades, occupations, and professions, made taxable by the several acts of Assembly of this Commonwealth ; showing the amount of the valuations, together with the amount of the several taxes assessed for County and State purposes in each township, and in the Borough of Gettysburg, in the County of Adams. Real Estate, Live Stock, Moneys, &c., at Interest, Turnpike Stock, Foreign Bank Stock, are subject to a tax of three mills on Real Estate-to wit :

the dollar for State, and two mills for County purposes.

Pennsylvania Bank Stock, Carriages, Occupations, Salaries, &c. are subject to a County rate of two mills on the dollar.

Excess of occupations over \$200, and carriages and excess of Furniture arc subject to one per cent. for State purposes.

Excess of Salaries over \$200 is subject to two per cent. tax for State purposes. Gold Lever Watches are subject to a tax of one dollar each.

Silver Lever Watches, seventy-five cents, and other Watches of the value of twenty dollars and over, fifty cents.




