I also make known and give notice, as in and by the 13th section of the aforesaid Act I am directed, that every person, excepting Justices of the Peace, who holds any office or appointment of profit or trust under the Government of the United States or of this State, or of any city or incorporated district, whether a commissioned officer or otherwise, a subordinate officer or agent, who is or shall be employed under the legislative, judiciary, or executive departments of this State or the United States, or of any city or incorporated district, and also that every member of Congress and of the State Legislature, and of the select and common council of any city, or commissioner of any incorporated district, is by law incapable of holding or exercising at the same time the office or appointment of Justice, Inspector, or clerk of an election in this Commonwealth, and that no Inspector or Judge, or other officer of any such election shall be eligible to be voted for.

Also, that in the fourth section of the Act of Assembly, entitled "An Act relating to elections and for other purposes," approved April 16th, 1860, it is enacted that the aforesaid 13th section shall not be construed as to prevent any Military Officer or Borough Officer from serving as Judge, Inspector, or Clerk of any general or special election in this Commonwealth.

It is further directed that the meeting of the return Judges at the Court House in Coudersport to make out the general returns, shall be on the first Friday succeeding the election, which will be the 17th day of October.

Election Proclamation.

PURSUANT to an Act of the General Assembly of the Commonwealth of Pennsylvania, entitled "An Act relating to the elections of this Commonwealth," approved the second day of July, A.
