

Election Proclamation.

PURSUANT to an Act of the General Assembly of the Commonwealth of Pennsylvania, entitled "An Act relating to the election of this Commonwealth," approved the second day of July, A. D. one thousand eight hundred and thirty-nine, J. D. C. LARRABEE, Sheriff of the county of Potter, Pennsylvania, do hereby make known and give notice to the electors of the county aforesaid, that a General Election will be held in the said county of Potter on the Second Tuesday (Thirteenth) of October, 1863, at which time State and County Officers, as follows are to be elected, to wit:

- One person for Governor of Pennsylvania.
- One person for Judge of the Supreme Court of Pennsylvania.
- Five persons for Members of the House of Representatives of the general Assembly of Pennsylvania, in conjunction with the county of Tioga, to represent the counties of Tioga and Potter.
- One person for Prothonotary and Clerk of Courts of the county of Potter.
- One person for Commissioner of the county of Potter.
- One person for Register and Recorder of the county of Potter.
- One person for Auditor of the county of Potter.
- One person for Coroner of the county of Potter.

I also make known and give notice, as in and by the 13th section of the aforesaid Act directed, that every person excepting Justices of the Peace, who holds any office or appointment of profit or trust under the Government of the United States or this State, or of any city or incorporated district, whether a commissioned officer or otherwise, a subordinate officer or agent, who is or shall be employed under the legislative, judicial, or executive departments of this State or the United States, or of any city or incorporated district, or of the State Legislature, and of the select and common council of any city, or commissioner of any incorporated district, is by law incapable of holding or exercising at the same time the office or appointment of Judge, Inspector, or clerk of an election in this Commonwealth, and that no Inspector or Judge, or other officer of any such election shall be eligible to be voted for.

Also, that in the fourth section of the Act of Assembly, entitled "An Act relating to elections and for other purposes," approved April 16th, 1860, it is enacted that the aforesaid 13th section shall not be so construed as to prevent any Military Officer or Borough Officer from serving as Judge, Inspector, or Clerk of any general or special election in this Commonwealth.

It is further directed that the meeting of the return Judges at the Court House in Coudersport to make out the general returns, shall be the first Friday succeeding the general election, which will be the 16th day of October.

I also here make known and give notice that the places for holding the aforesaid general election in the several townships and boroughs within the county of Potter, are as follows, to wit:

- For the township of Abbott, at the Germania Hotel in said township.
- For the township of Allegany, at the school house near the place formerly owned by Chester Andrews, in said township.

- For the township of Clara, at the school house near Sala Stevens, in said township.
- For the township of Eulalia, at the New Court House in the borough of Coudersport.
- For the township of Genesee, at the house formerly occupied by S. S. Rasco, in Ellensburg.
- For the township of Harrison, at the house recently occupied by Ira Bartholomew, in said township.
- For the township of Hebron, at the school house No. 5, near Henry Ingraham's, in said township.
- For the township of Hector, at the Sunderland school house, in said township.
- For the township of Homer, at the school house near Jacob Peet's, in said township.
- For the township of Jackson, at the house formerly occupied by B. Baras, now M. Chapman, in said township.
- For the township of Keating, at the house of Philny Harris, in said township.
- For the township of Oswayo, at the Centre school house in said township.
- For the township of Pike, at the house of Elijah Johnson, in said township.
- For the township of Pleasant Valley, at the school house No. 2, in said township.
- For the township of Portage, at the Sizer school house in said township.
- For the township of Roulet, at the school house near George Weimer's in said township.
- For the township of Sharon, at the Sharon Centre school house, near John Voorbes', in said township.
- For the township of Sweden, at the house of Aseneth Taggart, in said township.



WAR DEPARTMENT, PROVOST MARSIAL GENERAL'S OFFICE, WASHINGTON, D. C. June 11, 1863.

Notice.—The following will be published as a hand-bill or notice, by every District Provost Marshal, with such alterations as he may think particularly suited to his district. The object being to hasten and encourage enlistments in the Invalid Corps.

JAMES B. FRY, Provost Marshal General, MEN WANTED FOR THE INVALID CORPS

Only those faithful soldiers who, from wounds or the hardships of war, are no longer fit for field duty will be received in this Corps of Honor. Enlistments will be for three years unless sooner discharged. Pay and allowances same as for officers and men of the United States Infantry; except that no premiums or bounty for enlistment will be allowed. This will not invalidate any pensions or bounties which may be due for previous services.

The following uniform has been adopted for officers and men of the Invalid Corps: FOR OFFICERS: Frock coat of sky blue cloth, with dark blue velvet collar and cuffs; in all other respects, according to the present pattern for officers of Infantry.

Shoulder straps—According to present regulations, but worked on dark blue velvet. Pantaloon—Of sky blue cloth, with double stripe of dark blue cloth down the outer seam, each stripe one half inch wide, with space between of three-eighths of an inch.

Forage cap—Present regulation. For ENLISTED MEN—Jacket of sky blue kersey, with dark blue trimmings, cut like the cavalry jacket, to come well down on the abdomen.

Trowsers—Present regulation, sky blue. Forage cap—Present regulation. Men who are still in service and unable to perform effective field duty, may be transferred to this corps.

Medical Inspectors, Surgeons in charge of Hospitals, Military Commanders, and all others having authority to discharge, under existing laws and regulations, are forbidden to grant discharges to any men under their control who may be fit for service in the Invalid Corps.

For the convenience of service, the men will be selected for three different grades of duty. Those who are most efficient and able-bodied, and capable of performing duty etc., will be armed with muskets, and assigned to companies of the First Battalion.

Those of the next degree of efficiency, including those who have lost a hand or an arm, and the least effective, including those who have lost a foot or a leg, to the companies of the Second or Third Battalions; they will be armed with swords.

The duties will be chiefly to act as provost guards and garrisons for cities; guards for hospitals and other public buildings; and as clerks, orderlies, etc. If found necessary they may be assigned to forage etc.

Acting Assistant Provost Marshals General are authorized to appoint Officers of the Regular Service, or of the Invalid Corps, to administer the oath of enlistment to those men who have completely fulfilled the prescribed conditions of admission to the Invalid Corps, viz:

- 1. That the applicant is unfit for service in the field.
- 2. That he is fit for the duties, or some of them indicated above.
- 3. That if not now in the service, he was honorably discharged.
- 4. That he is meritorious and deserving.

For enlistment or further information apply to the Board of Enrollment for the district in which the applicant is a resident.

A Joint Resolution proposing certain Amendments to the Constitution.

Resolved by the Senate and House of Representatives of the General Assembly of Pennsylvania in General Session, That the following Amendments be proposed to the Constitution of the Commonwealth, in accordance with the provisions of the tenth article thereof.

There shall be an additional section to the third article of the Constitution, to be designated as section four, as follows:

"Section 4. Whenever any of the qualified electors of this Commonwealth shall be an actual military service, under a resolution of the President of the United States, or by the authority of this Commonwealth, such electors may exercise the right of suffrage in all elections by the citizens, under such regulations as are or shall be prescribed by law as fully and effectually as if they were present at their usual places of election."

There shall be two additional sections to the eleventh article of the Constitution, to be designated as sections eight and nine as follows:

"Section 8. No bill shall be passed by the Legislature containing more than one subject, which shall be clearly expressed in the title, except appropriation bills.

"Section 9. No bill shall be passed by the Legislature granting any powers or privileges in any case where the authority to grant such powers or privileges has been or may hereafter be conferred upon the Courts of this Commonwealth."
